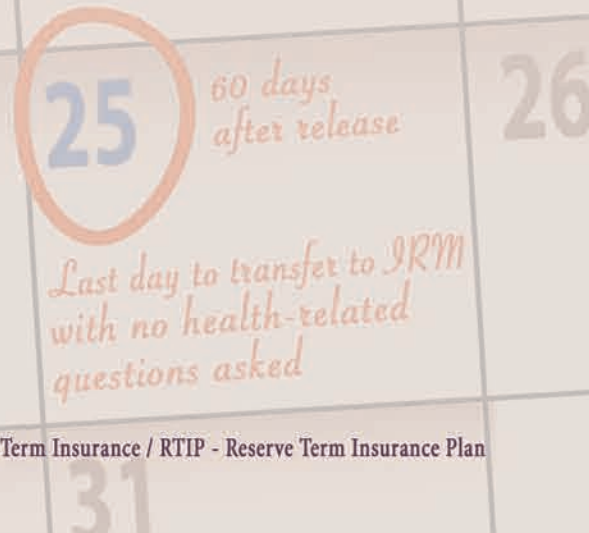

What is Insurance for Released Members?

Insurance for Released Members (IRM) is term life insurance tailored for former members of the Canadian Forces (CF) and their spouses. You will receive sound advice from a licensed representative who understands your insurance needs and is paid a salary – not commission.

Some of the features of IRM are:

- ☛ coverage for accidental dismemberment (lump-sum payment);
- ☛ free Dependent Life (DL) coverage in the amount of \$10,000 per dependent child;
- ☛ surviving spouses of former CF personnel can enrol in/or maintain their existing IRM coverage; and
- ☛ retiring members who do not have SISIP Financial Services (SISIP FS) coverage (OGTI or RTIP)* or former members can apply for IRM but must be age 65 or less and provide proof of insurability.



*OGTI - Optional Group Term Insurance / RTIP - Reserve Term Insurance Plan
